# SSSR Thematic Sessions "Religion in Global Perspective"

### Understanding Desecularization: Conceptual and Comparative Perspectives (B-10)

Friday, October 29th, 9:45-11:15 AM

In recent years, resurgent religions' influences on societies, cultures and politics worldwide have attracted a growing attention of social scientists. Yet, there has been remarkably little effort to conceptualize desecularization and heuristically apply this theoretical notion to comparative studies of resurgent religions. This session is designed to address this gap by offering a conceptual framework and comparative perspective on desecularization and religious resurgence in Europe, Russia, and China.

### Going Global with Your Research: Why and How (C-11) Friday, October 29th, 1:00-2:30 PM

This session is designed to provide advice to graduate students considering or preparing to study religion outside the United States, Canada, or Western Europe. Panelists will talk about how they developed an interest in the particular religion(s) and/or place that are the focus of their research, the value of taking a global perspective on their research as a whole, and challenges they have faced along the way. Panelists will also address how to conduct research in a variety of places around the world using a mix of methodological approaches.

### When Counting Counts: New Sources of International Data on Religion (D-7)

Friday, October 29th, 2:45-4:15 PM

One of the most significant deterrents of cross-national research on religion has been a lack of quality data. Recently, however, there has been a growing number of multi-nation surveys and cross-national data collections with improved measures on religion. This session will (1) review several of the recent new data sources now publicly available, (2) introduce some of the data collections in progress, (3) identify public archives and web sites where international data can be downloaded, (4) target new areas for future data collections, and (5) illustrate how the data are being used in existing research.

### The Kingdom, the Power, the Glory: Religion and Political Life (F-15)

Saturday, October 30th, 9:45-11:15 AM

Drawing on papers based on four unique empirical cases, this session will explore the intersection of religion and political life in both contemporary and historical contexts. The papers focus on the ways that religious expression and faith-based political mobilization help us better understand different cultures, faith traditions, and nation-states.

### Religious and Social Movements Around the World (G-8) Saturday, October 30th, 2:00-3:30 PM

This panel consists of four scholars who study religious movements with origins in four different countries: the Philippines (Gawad Kalinga), Japan (Soka Gakkai), China (Falon Gong) and Africa (Christian church movement). The organizer/moderator will pose several, relevant movement related questions that will be addressed by each panelist from the perspective of the specific religious movement he/she studies. These include: who were the "carriers" of the movement as it spread beyond its country of origin to other countries? What types of adaptations/changes occurred in the movement in the process of settling in a different social and religious context? Who finances the activities and sustainability of the movement in its various locations? Has the movement experienced criticism/hostility from people/groups, either in its country of origin or in new locales to which it migrated?
